Pee Dee Regional EMS announces the beginning of a recurring hybrid CEU program. Students may work at the pace that works for them completing the required course work online using My Brady Lab to progress plus the online access to the e-text for the particular certification level. Each lesson progresses through the materials in a logical order. You must proceed through the materials fulfilling the prerequisites before proceeding, (example: you can't do the chapter post-test before doing the pretest.) Once started the student will have 45 days to complete the didactic requirements.

At that time you will be scheduled for a practical skills competency day in which you will successfully demonstrate mastery of all skills for the level. This takes approximately 4-8 hours depending on the number of students enrolled. Successful completion of the materials requires both components to be completed.

The program may be used as part of the recertification requirements and gives the participant the needed hours of CEU credit. The program is active for all three current levels of EMS certification, EMT, AEMT and Paramedic.

What does this get you? The NREMT has determined that these areas need to be covered and the State and Individual areas cover materials specific to SC. Rather than having to find a class here or there to fulfill your recertification requirements everything is packaged into one institution. You complete the information on your CIS or NREMT profile and you are automatically updated. Since skills evaluations are included in the program, your Medical Control can feel confident in your competency.

This program is designed for both the individual needing to make certain their certification remains current whether the are in an inservice program or not. The program will run on a recurring basis so that you don't have to wait on (recertification time) to get your training completed. As an Advanced Level Training Institution our programs are recognized and accepted by both SC and NREMT.

State only EMS personnel please note: These hours are totals for two years. This means that you must complete the materials twice (once in your first two years of certification and again in your second two years.)

## How to get started:

Complete the Registration form found under the Courses tab of the web site. Under the course click on the "hybrid" course option for the selected level. Once received you will be invoiced for the course and once paid, you will be enrolled into the course. You may begin working immediately upon enrollment.

Your instructor will make contact with you and explain how the navigation through the program works. They will also notify you when you can report for the skills evaluation portion of the course.
